City Council Regular Meeting Minutes Monday, March 7, 2022

Auburn Volunteer Association – Sharon has contacted DCCCA and will have a meeting with them at the community center and would like meeting date/info on website. DCCCA is providing free naloxone (Narcan) nasal spray and training to community organizations and any Kansas resident. Naloxone is an opioid overdose reversal drug that counteracts the life-threatening effects of an opioid overdose. Naloxone is available to any resident or organization in Kansas upon request.

Auburn Volunteer Association will be hosting a quarter mania fundraiser April 30<sup>th</sup> to raise funds for canine officer vests.
