#### **Previous Meeting Minutes**

Approval of September 6, 2022, meeting minutes reviewed. Council Member Potter motioned to approve meeting minutes. Council Member Randles seconded the motion. Motion approved Unanimous.

Detailed report of payment of invoices and checks included in meeting packet for all to review. Council Member Bryan motioned approve accounts payable ledger of \$116,693.90 including Payroll. Council Member Stewart seconded the motion. Motion approved Unanimous.

## **City Attorney Todd Luckman**

Attorney Luckman presented letter sent to Warmister at their request in reply to Utility Solutions unwilling to pay them claiming the City of Auburn not fulfilling their payment to Utility Solutions.

#### Superintendent Clinkenbeard

Case loader sold on purple wave for \$24,000 Generator sold on purple wave for \$1,850

Requested to attend KCC Conference October 25th-27<sup>th</sup> in Manhattan. Expenses total \$465. Council Member Bryan motioned to approve expense of \$465 for Superintendent Clinkenbeard to attend conference. Council Member Stewart seconded the motion. Motion approved Unanimous.

Packet from Proseal Pavement Preservation Program discussed.

Bettis street quote discussed. Council Member Potter motioned to approve expenses for 8<sup>th</sup> street edge mill and 2" overlay for approximately \$48,900, expenses for Hanover to replace the existing deteriorated pipe with concrete pipe, install a concrete flume in the ditch and patch asphalt for approximately \$31,750, and crack and seal with two coats of sealer at the parking north of ball field, city hall, civic center, and heritage park for total expenses not to exceed \$98,000 after consult with City Engineer Pat Cox. Council Member Arpin seconded the motion. Motion approved Unanimous.

#### Code Compliance discussed.

Parking across from the school interfering with bus transportation on Milton Street discussed. City Attorney Luckman will draft a prohibited parking ordinance asap. Special Meeting will be held to discuss ordinance.

## City Clerk Temple

Requested to pay officers Robert McClelland and Joe Forshee \$5 additional per hour for the travel time to take the new PD truck to Garden City to have it outfitted. Council Member Bryan motioned to approve the additional \$5 per hour for the travel for both officers. Council Member Randles seconded the motion. Motion approved unanimous.

Brownville Heritage Park address discussed with City Attorney Luckman.

Council Member Bryan attended the county commissioner meeting. The county will hire and pay for a grant writer for an Auburn turnpike exit and California Ave exit together.
