# City Council Regular Meeting Minutes Monday, March 6, 2023

Central City Basin Storm Water Improvement bid letting was held March 1, 2023. Low bid was submitted by Bettis Construction, Topeka, KS. Recommendation to approve Bettis Construction to complete work pending CDBG grant approval/authorization. Council Member Bryan motioned to approve acceptance of Bettis construction bid of \$488,104.20 pending CDBG approval. Council Member Arpin seconded the motion. Motion approved Unanimous.
