Approval of March 6, 2023, meeting minutes reviewed. Council Member Stewart motioned to approve meeting minutes. Council Member Potter seconded the motion. Motion approved Unanimous.

Detailed report of payment of invoices and checks included in meeting packet for all to review. Council Member Bryan motioned to approve accounts payable ledger of \$94,086.53 including Payroll. Council Member Stewart seconded the motion. Motion approved Unanimous.

Citizens Forum

Fair board representatives Tori Douglas and Misty Brobst requested permission to shut down 11th street between ball field and community center on Saturday from 7am - 11pm to provide additional room for vendors and a street dance later in the evening. Council Member Bryan motioned to approve closing 11th street between the hours of 7am – 11pm. Council Member Potter seconded the motion. Motion approved Unanimous. Use of the civic center parking lot was also requested for additional vendor spaces. Auburn Fair is scheduled for September 22-23, 2023.

Motion approved Unanimous. Review of streets in need of repair. If mill and overlay work is planned for the year, the work needs to be scheduled in advance with the contractor.
