Current wording states, "Either party may terminate this agreement at any time, by giving written notice to the other, specifying the date of termination, such notice to be given not less than three (3) days prior to the date specified in such notice for the date of termination."

Recommended wording of "Termination notice of this agreement of less than (3) days prior to the date specified forfeits all deposit amounts." In addition to current wording. Council Member Stewart motioned to approve additional wording to existing contract. Council Member Bryan seconded the motion. Motion approved Unanimous.
